Rules and Guidelines Governing the Championships

The rules of International Netball Federation (INF), in conjunction with the rules outlined below, governs this championship.

1. The championship shall consist of three days of play commencing on:

Saturday, July 22nd, 2017 at 9:30 AM ET:

A. Club Championships (Open)

Categories: Female, Male, and Mixed²;

Entry Fee:	Members	US\$200.00
	Non-Members	US\$250.00

B. Junior Club Championships (U21)

Categories: Female only: (must be U-21 at 1/1/2017)

Entry Fee:	Members	US\$160.00
	Non-members	US\$180.00

Friday, July 21st and Sunday, July 23rd 2017

- C. **State Association Tri-Series Championships** – Two teams will play for supremacy over three 1 hour games starting with

Game 1 – Friday, July 21st at 6PM

Game 2 – Sunday, July 23rd at 10:30 AM

Game 3 – Sunday, July 23rd at 4PM

All entry fee(s) shall be non-refundable. Sections may be amalgamated dependent on number of entries.

2. The tournament shall be open to all USA Netball members or bona fide members of another INF and/or AFNA registered governing body. Non-members of USA Netball will be allowed to compete as above but their scores shall count towards the Invitational Competition tally. ***Only bona fide USA Netball member clubs and State Associations may participate in the National categories of the championships.***

² Mixed Teams shall have no more than 3 male players with one male in each third at the start of play.

- Registration for the Club Championships shall take place on Friday July 21, 2017 at the Candlewood Suites, 9740 Commerce Center Ct, Fort Myers, FL from 8-9 PM ET. Players for each team participating in the National Clubs Tournament must be bona fide members of that club as set down in the USA Netball Constitution. Confirmation of membership will be checked.
- For participants in the Under 21 category, a valid form of identification must be provided at registration to verify age.
- The Parade and Presentation of Teams shall commence at 9:30 a.m. on Saturday, July 22nd, 2017. Matches will commence at 10:00 a.m.

Umpiring

- The Umpire's decision is final and shall be given without appeal. Umpires will be appointed by the USA Netball Technical Director in conjunction with the Match & Tournament Director and Tournament Referee(s). *USA Netball reserves the right to test Level 2 and 3 USA Netball umpires at this event.*

Games & Points

- The tournament draw will be circulated one week prior to commencement of the tournament.
- Points shall be awarded as follows:

Win: 5 points; Draw: 3 points; attaining more than 50% of the winning team's score: 1 point. If any team fails to take the court at the appointed time, their opponents shall be awarded 5 points. The non-defaulting team will be awarded the average number of goals scored against the defaulting team by other opponents in the same section. This will be calculated at the end of the round of games in that section.
- In the event of a tie on points when group placements are determined, goal difference (goals for minus goals against) shall be used to break the tie. If there is still a tie, goal average (goals for divided by goals against) shall be used to determine the higher placed team. If there is still a tie after invoking these two methods, a match consisting of 2 minutes each way between those tied teams shall take place. During the semi-final and final rounds, if the match is drawn at the final whistle, 2 minutes extra time each way will be played. If at the end of the extra time the game is still drawn, the scoring/time-keeping officials shall signal end of extra time but play will continue until one team leads by 2 goals. That team will then be declared the winning team.

Time

- The duration of each match shall be announced at the time that the draw is published.
- There will be **no stoppage time** and **no injury time**. In the event of an injury, the player(s) involved shall be removed from the court immediately and play continues. In the event that a serious life or limb threatening injury occurs, the umpires have the discretion to call time until that player maybe safely removed from the court by qualified medical personnel; otherwise an injured player will be removed from the court immediately with a

substitute filling only that injured player's position. Team changes may ONLY take place at an interval. Random team **changes within the course of play are not permitted**. The umpires shall deem any infringement of this rule within the auspices of the off-side rule and players must return to their original starting position. No delay of play will be permitted while this takes place and the non-offending team can continue play.

Start of Play

12. The umpire's whistle, in conjunction with the timekeeper's signal, shall indicate the start and end of the game and each interval. The umpire's whistle shall determine "time".
13. Players are allowed to register and play on only **one** Club team in each section (all female, all male or mixed) for the duration of the Club Championships but players may compete in two sections, i.e. female and mixed or male and mixed. Similarly, players are allowed to register and play on only one State Association or Invitational Elite representative team for the duration of the Championships.
14. **Each registered team, regardless of the section (all female, all male or mixed) participating, MUST consist of a minimum of five and a maximum of 12 players.** In the mixed section, only three male players shall be on court at any one time. The male players shall start and remain playing as a defending player, a center court player or an attacking player in line with those positions' designated playing areas.
15. Captains need to toss and report the result to the appropriate scorers' table at least five (5) minutes before the start of each scheduled game. They shall notify the umpires in a timely manner.
16. All teams must be ready to play within one minute of the end of the previous game. See Rule 8 above.

Awards

17. ***A monetary prize of US\$2,500 shall be awarded to the first place team in the Open Female Club Category regardless of whether the team is from within the USA or from overseas.*** Trophies and/or medals will be awarded in each respective category of the Championships. Other prizes will be announced at registration, if needed. National Club championship is open only to bona fide members of the USA Netball Association.

Other

18. No updates to a registered Member's club roster shall be permitted within 14 days of the commencement of this tournament. Such membership registration together with tournament registration forms will be ratified by the Membership Director prior to the commencement of the Championships. It is the responsibility of the registered Member Club or Association to ensure compliance with this rule. Copies of registration forms must be available for review during the tournament registration process.
19. The tournament referee(s) shall have the right to amend, delete or add to these rules:

- a. Prior to the Championships. Teams will be notified of any changes within 24 hours of the change.
 - b. During the Championships notification will be given to teams within five minutes of any such amendment.
20. Any matters outside the parameters of these rules shall be resolved at the discretion of the tournament referee(s) if such matter(s) should occur during the tournament. All other matters will be dealt with by the USA Netball Association Match & Tournament Organizing sub-committee.
21. Any person (of whatever capacity) who abuses (physically or verbally) another attendee (of whatever capacity) or who deliberately causes damage to any equipment, fixtures or furnishings at the tournament shall be removed from both the competition and the premises and may be precluded from participating in any future USA Netball event as well as face legal charges.
22. Every player and championships attendee shall adhere to the standards of behavior as outlined in the USA Netball Code of Conduct which will be available at the championships.
